- B. Chief Winfrey No fires, triple digit calls in January. Feeling the effects of high call volumes. Staffing Issues affecting the ambulance company which affects how long fire department remains on scene. Rogue Valley Fire Chief Association has changed the call signs.
- C. Chair Hohenstein, Planning Commission Land Division proposed for west end of Hudspeth, applicant did not show. Continued until next meeting. Shady Cove Smoke Shop was approved with conditions. Two code enforcement issues, neither owner showed. Matter continued to next meeting.
- D. City Administrator Received Small City Allotment Grant for Train Lane, \$78,647. Received payback on RVSS \$96,000. Using a lot of ¾ minus to fill potholes. Biobags near storm sewers only able to obtain 20 bags because of the high demand. More labels are on the way for no oil, no dumping. 2000-gallon water storage tank has been installed at City Hall. In discussions with Chase on bench placement. Paint Care will be in Shady Cove in September. FCC radio station license was renewed. The City responded to the LUBA appeal on Mr Kretzer Bridge. Tired of dissention and the hate and discontent. We are a really good community it's time to get back there.
- B. Councilor Murders Couldn't say that any better. Voted no on the Events Committee, being hopeful that concerns are a non-issue. Look forward to raising my daughter in a community that supports each other. Think we are on the right track.
- C. Mayor Tarvin RVCOG is requesting the city to send support letters to the Ways and Means Committee for Alert Wildfire. Reminder for upcoming trainings with CIS. New Councilors will have to do an SEI filing by April 15^{th.} Budget committee no later than April 18. Oregon Broadband office, IIJA, covers transportation, water, broadband, wildfire mitigation. Unsure of how much will be given to Jackson County. Two fires in Cave Junction shows us that we still need to pay attention to fire danger. Important to work on getting the fuels down. What we get for our taxes a particular property paid \$4300 and only \$196 goes to Shady Cove. Last meeting Commissioner Ball commented on the Streets, the Council does not have a final report yet to put on our agenda. There are some concerns regarding properties that were approved with conditions on their permits. Council to task Planning Commission to investigate who has not met those conditions. Planning Commission minutes need to be completed.
