IV. STAFF REPORTS

- A. Deputy Violette Busy time of year. Suicides and domestic violence calls are on the rise in the area. New Program that will help Deputy's track fire evacuation.
- B. City Administrator City hall does not dispatch calls to the Sheriff. Please contact 774-6800 the main non-emergency number. Most often the Deputies are here in the office to do paperwork, take a break and may not be able to assist you with something that is not an emergency. Please contact Dispatch directly. ODOT has put no parking signs on the lot south of the Shady Cove welcome sign. CSO has been working on the new enhanced weed abatement ordinance. Limb trailer was not utilized enough by citizens while it was up. Reducing the fuel load on our properties is the best way to prepare for fire season. A letter will be sent to the residents in the red zones. In the near future the CSO will be enforcing the ordinance. The Fire Chief and staff drove through the City to determine if an emergency vehicle can travel through all areas and make tight turns.

ODF is providing assistance for the dog walk. Once the riparian permit is approved we will remove brush and replant native plants. ODF is giving \$500 per acre to assist with cleanup. No news from LUBA. Access is now able to help with water and sewer bills. Jackson County Domestic and Well Assistance program to owners who have challenges with their wells, up to \$7500 per person. All of this information is on the website. ODOT is pursuing the safe route to school grant. This would extend the sidewalks farther south. Notice of Public Hearing on May 2nd for a commercial operation of processing of aggregate, located on Hwy 227. Jackson County has tentatively denied the petition. Council can comment if needed. New Shady Cove map coming out. Spencer cleaned the pine needles and other debris in between City and school. SOREDI has a meeting coming up about realtors in the area, April 27th in Grants Pass. Cameras for the wildfire have been put up, closest one so far is in Cave Junction. Auditors are working diligently remotely requesting items as needed. The City needs new barricades. Councils direction is needed to understand if the City should have a facility use fee when loaning equipment. Feasibility study last week was voting on the approval of the company. No contract or proposal has been signed. RH2 worked on the original Shady Cove waterworks deal. Initial scope for the grant was for government buildings in the area.

Council directs City Administrator to write a letter opposed to the aggregate company proposed on 227.

Susan Pemberton – Would recommend barriers be update to have flashing lights. There is still a vacancy on the Emergency Management Commission. Thank you for the explanation on feasibility study. To be proactive with the American Rescue funds and what are we doing as a City to secure a municipal water system or other areas that are as equally important.

John Ball – LUBA is scheduled on May 2^{nd} , encourage the Council to be there. Hiland water can tell the City what it cost to get water to the school, City Hall and library without spending money on the feasibility study. City Administrator explained the differences in the grant.

VIII. COUNCIL COMMENTS ON NON AGENDA ITEMS

- A. Councilor Taylor We need to work on clearing the fuel for wildfire. There is a lot of advertising going out to encourage cleanup. It seems as though we are not getting a response. We want to see action and it may come down to citations. The word needs to get out that this is a serious situation and it could mean lives. We came so close to losing this town last year. If it wasn't for the wind change, we would be reduced to rubble. Is or putting some teeth into citations. May 17th is the primary and everyone needs to be registered and show their party affiliations by April 28th. We have a lot of people running. Position called precinct committee position available. This is a position to get everyone motivated to vote. It all starts right here.
- B. Councilor Murders The fire prevention and protection is so critical but unsure of how else getting the message out. Help your neighbors. It's a scary time with drought and fire danger we are in.
- C. Councilor Winfrey Wildfire prevention is something we should look at next year as a whole. Implement some of the items for the fire station open house. Chance for \$500 for cleanup. May 7th is too quick to pull off City-wide. The City and the fire department are working on a fire wise garden. The Events Committee has met three times and excited to hear what they had planned. Hoping some things would have been brought forward tonight.
- D. Councilor Evertt Reiterate domestic and public well assistance program is available. KOBI or KTVL 10 have stories on it. \$7500 per well owner. If you are having issues with your wells, please look that information up.
- E. Mayor Tarvin Tool kit sent out for fire community preparedness for May 7th. It gives a lot of good information. It has other links with really good information. Looking at our red zones we have plenty of time to get the fuels down. Really disappointed that we only dumped the trailer twice. Driving around the town you can see so much that needs to be done. Sent Mr Corrigan something from Fire District 3 in regards to missionaries have a grant to help clean up your property. You have the labor to help you get this cleaned up. Going to be a broken record. We were saved by the wind change. If it didn't change, we would be rebuilding now. The little things that we do is a lot. Help your neighbors out. Budget Committee meeting coming up. Seven15 Ministries may be able to assist with cleanup. 4.5 million was awarded in Oregon for Alert Camera system. According to RVCOG some of the money will be used for alert camera system in southern Oregon region. Chipper events coming up, residents will be notified. Oregon Mayors Association have resolutions condemning the actions of Russia. Sample resolution is available for council if they would like to participate. Events Committee has set dates for music in the

park, first is on May 21st, it is a jam session, any ages are welcome. June 18, July 16, September 17th (50th Anniversary Celebration). Digital and hardcopy Events Calendar will be created and posted around community.
