- B. Ruth Strozewski Events Committee 50<sup>th</sup> Anniversary, scavenger hunt map showing all businesses participating, over 30 businesses. Silent auction, 50/50, food vendors, craft vendors, and a clown.
- C. City Administrator Graffiti on bridge that needs cleaned up immediately. Disagreement between the Engineer and ODOT, they want to put in a crosswalk that goes nowhere. It would add about \$10,000-\$15,000 to the Cleveland Street project. Have had complaints from residents regarding excessive wood and vehicles for sale on commercial lots. CSO addressed both of these. Still working on compliance with 3 riparian areas along the river. Waiting for a company to assist with removal of blackberries, replacing over 2200 square feet, replacing with native species, Oregon Grape, and Willows. Had to do more work on the climbing equipment, not cheap to replace. Someone did some carving on the picnic tables so had to have them sanded

and painted before the 50th. Had to replace sprinkler heads in the park. Still trying to come up with a plan for the front with the Firewise community, and free up view on corner. Working with public works, get new tires, the tailgate of the trailer fixed. Got approval from Chase to put the bench out front, should be finished between the 29<sup>th</sup> and the 30<sup>th</sup>, only stipulation was Chase does not want a trashcan there. Auditors were out last week, will be having an accountant from RVCOG coming out to assist. Looking at a couple businesses operating without licenses.

Mary Pulcini has a birch tree that she is willing to donate. Also has a question regarding vandalism and rewards. Deputy suggested putting info on FB page, or putting the word out, or putting a sign that the area is under surveillance. Council will discuss this.
