Still trying to come up with a plan for the front with the Firewise community, and free up view on corner. Working with public works, get new tires, the tailgate of the trailer fixed. Got approval from Chase to put the bench out front, should be finished between the 29<sup>th</sup> and the 30<sup>th</sup>, only stipulation was Chase does not want a trashcan there. Auditors were out last week, will be having an accountant from RVCOG coming out to assist. Looking at a couple businesses operating without licenses.

Water Crisis

As we all know, wells are going dry and/or severely slowing down, wells are showing more and more arsenic, we have a severe lack of workable fire hydrants, and the lack of water is having a negative effect on our business community. These problems are real, these problems are here to stay, and these problems have no easy fix. Any solution we adopt will take years and years to realize, and hence why we must stop kicking this can down the road.

We are all aware that water initiatives in the past have failed, but we would be wrong to use those attempts to justify doing nothing now. The climate today is not what existed in the past. Additionally, we can take what was done in the past and use it as "lessons learned" going forward. We can succeed if we do this smartly and systematically.

The Concerned Citizens of Shady Cove do not see tonight's water discussion as a "one and done" session. Rather, we view this as the start of an ongoing process. This issue must be carefully discussed and considered, with a goal of defining the problem, creating a long-term plan to address the problem, and then systematically working the plan to complete each part.

Additionally, we don't see this as a Council-only issue. Water involves the entire City, and as such, the public must be included in all aspects of this process.

During your discussions tonight, we request that you consider our approach and make a motion to acknowledge that Shady Cove has a water crisis, and that this discussion item be included in the agenda each month with the goal of creating a long term plan that can be worked in a controlled manner to address the urgent water needs of Shady Cove.

If tonight can be the start of a fruitful Council and public relationship, Shady Cove will benefit greatly.

# **CONCERNED CITIZENS OF SHADY COVE To: City Council**

October 20, 2022 Boat Ramp/Park

I am here speaking on behalf of myself and the Concerned Citizens of Shady Cove. Council is aware of the modifications proposed by Jackson County Parks to the Upper Rogue Regional Park (aka Shady Cove Park). We feel it is without question, the most pressing issue in our City at this time. The Council needs to address this issue immediately.

As we all know, Jackson County Parks held an open house on Oct. 13, 2022 to allow input from citizens from the entire county. Four concepts were displayed and the Concerned Citizens of Shady Cove came to the consensus that not one of the initial concepts is acceptable. We believe that City leaders understand the importance of the park as it currently exists with respect to the grass, trees and open areas for residents to enjoy. We also understand the need for repair and improvements to the boat ramp itself. These two things are NOT mutually exclusive by any means. One can and should exist with the other. We should and must have a more efficient boat ramp for our commercial rafting companies, guides and recreational users, while maintaining and improving the park setting for future generations of residents that follow.

The Concerned Citizens of Shady Cove are asking our City Council and Mayor to request in writing to Jackson County Parks, that turning Shady Cove Park into a Boat Ramp facility be tabled until all views are discussed and negotiated with the City of Shady Cove. The park is the center of this City and therefore any major decisions involving this park should be coordinated with the City.

The Concerned Citizens of Shady Cove would like the Council to revisit the option of acquiring Shady Cove Park from JCP. Much work and effort was put into that possibility in 2019 only to have it tabled at the last minute by the county. Many questions exist as to the abrupt change of heart by the county, but one that I don't see anywhere is the desire of Shady Cove and area residents to volunteer and make this park the centerpiece of our small City on the Rogue River.

Area residents, along with the Concerned Citizens of Shady Cove are requesting that Shady Cove City Council add this item to their agenda at least once every month. This would enable true transparency in the dealings of Shady Cove Park, keep the residents updated and allow them to participate in this most important process that truly affects each and every one of us.

Let tonight be a time where personal differences are put aside and the voices of the people of Shady Cove and the surrounding area are heard, listened to, and acted upon for the betterment of Shady Cove.



### Re: Fixing the Shady Cove boat ramp

We have examined the conceptual designs that Jackson County and the Marine Board have developed for replacing Shady Cove's public boat ramp. Their concepts would use a lot of public money (as much as \$1.5-2.0 million) without being fully effective at addressing the specific problems experienced at the ramp. The designs would also be likely to create conflicts associated with jet boat use beyond that of emergency responders and would diminish the value of Upper Rogue Regional Park as Shady Cove's only public riverside open space. Replacing trees and shaded grass with varying expanses of asphalt and concrete, as suggested in their conceptual designs, would make the park a less appealing place. Less appealing for community members, for visitors to town, as a venue for large events, and for customers of river businesses.

These issues might still be resolved in favor of our community's interests if the City would ask Jackson County and the Marine Board to give the City a month or so to have a local working group use the material that has been developed to rough out a new design concept to carry forward. This is something we would support, would participate in if asked, and hope you will give serious consideration. The alternative is to fail as a functioning community and wait to see what comes next from the County and Marine Board. Those who attended an "open house" the County hosted last week on their concepts got a peek at where failure on our part might lead. The view was not appealing to anyone present, including the County and Marine Board representatives who received consistently negative public feedback. That feedback surprised them, a clear indication that our community's interests here have been misunderstood or not yet given much consideration. We, and they, simply must do better.

Thank you for considering our thoughts on this matter.

#### STATEMENT REGARDING THE USE OF SHADY COVE PARK

Good evening Mayor, Councilors, and Friends. I am Steve Smith and I have lent my 30 years experience in Municipal Government to the diverse community that needs and desires Shady Cove Park to remain a multi use facility. Not the diversity we will see in Heaven, but diversity in life experience, in perception, in needs, in desires, and in expression. We are not one voice, one thought, and as I'm sure you have seen and will see again tonight, we all express ourselves differently. So while it is of the utmost importance that each and everyone is heard, my first ask of you tonight is to feel. Feel their words. Feel their struggles, feel their passion, feel their needs, and above all else feel their fear.

Our entire world has been in turmoil the past few years. We are a world in conflict. This community hasn't been at peace in years, we have been threatened by fire, COVID and financial instability. All has changed our way of life. All of us have struggled. Some have suffered. It is not hard to imagine that you, and all that are responsible for the public's well being, have struggled and suffered that much more due to that responsibility. I want to acknowledge your struggles and offer my appreciation for your willingness to accept such burden and for your sleepless nights. The struggle is indeed, real.

I'd also like to acknowledge that you have a really hard job. The decisions to be made in Municipal Government are difficult. Tonight you're going to be asked to make some hard decisions, agendized and otherwise. You are going to be asked to change course. If you are at the helm for the right reasons, and I have no reason to believe otherwise, in a few minutes I'm going to present to you perhaps the easiest decision you have ever made as an elected official. Knowing your job comes with little reward, I'm also going to give you an opportunity to go home tonight with the satisfaction of a job well done. One of those little rewards.

A fair representation of our diverse community has gathered to formulate an effective plan to be heard. We have one objective. We have multiple needs that require a multiuse facility. We make our living on the river, using the ramp. We launch our private watercraft at the park, We attend special events at the park, We walk our dogs at the park. We celebrate family milestones. We bring our kids to swim at the only public, safe location on the river in town. We talk to God. We reminisce. We come to the park to grieve. We bring our disabled relatives to fish from the platform. We seek the shade the trees provide during the hot summer months. We collect cans and bottles to supplement our income. We bring our children to play. We bring visitors to show them the gem of Shady Cove. We seek solitude. We are the 90% of the community whose only public access to the river is the park. The park is more than a piece of land. This park has soul. Our souls. Our commonality, other than our objective, is fear. We fear that Shady Cove Park will become the same type of low maintenance, little attention facility as Takelma and Dodge Bridge Parks. To see our fear look no further than the blight that is the parking lot owned and operated by the County across the street from the park. The lot is full of noxious, highly invasive weeds. The storm catch basins are full of debris that will end up in our waterways during the next storm. Parking stops are broken, it is an

embarrassment. Not the County's embarrassment, ours. We fear that Shady Cove Park will become an unusable facility for most. We fear that we will lose Shady Cove Park as a Stay and Play facility and it will become a Park and Disembark facility.

The decision I'm asking you to make tonight not only should be the easiest of your tenure as elected official, but quite honestly make all further decisions regarding Shady Cove Park that much easier. I'm asking you to join us. Not as leaders. Don't have any, don't want any. But as a voice, as a segment. Let us fill your box with our tools. Share our struggles. Share and feel our fears. It really is that simple and easy.

A few weeks ago I would have predicted that although we may have a struggle, ultimately it was so blatantly obvious that Shady Cove Park is tied to the community's well being that it was a no brainer. Now that the Jackson County Government process and procedures is a part of my life experience, I offer no such prediction. What I am certain of is this. We will mourn the loss of the park together or we will celebrate it's revitalization together. Either way that is what so many of you have been seeking. Unity.

Again, if you make this one easy decision first and make it known to us, the next decision to change course will be that much easier. You will not only represent us, you will be us.
