V. STAFF REPORTS

A. Deputy Amaya - Month of March they had 261 calls. 90 traffic stops and domestic calls were up, with 9 this month. The school traffic lights are now working. Had a burglary at Fly Casters Rv Park and the suspects were found and arrested. They had 4 other burglary charges and also pulled almost 50 grams of Fentanyl out of the vehicle. A lot of the property was recovered. There have been a lot of issues at Shady Cove Automotive with someone going in behind the fences and siphoning gas out of several vehicles. Little Monkeys has a bus in the back shared lot that had gas siphoned out of it and also was broken into and couple items were taken. Fishin' Hole has a van and there was someone living in it and also gas was siphoned out of it. Suspect has been identified and a lot of property was recovered under the bridge next to Miguel's. They are hoping to locate and arrest him.

B. Commission/Committee Reports:

Planning – Commissioner Stirling- Meeting on March 23 was a type three hearing regarding the diesel repair shop with requirements and conditions. In the future there will not be a license issued until all of the conditions are completed. Commissioner Magill asked that she no longer be the Vice Chair. Commissioner Richardson has now been elected to be Vice Chair for the Planning Commission.

Mayor Ball – Thanked Commissioner Stirling for his knowledge, expertise, and professionalism with customers that go through the Planning Commission.

Parks and Rec - Commissioner Pulcini- They have a few events potentially scheduled to discuss and get approved.

Councilor Nuckles – She is very impressed with the Parks and Rec group and how they include the public with their input and listen to the new ideas they bring forward. The work they are doing will be very visible with the people of Shady Cove.

Mayor Ball – Let Parks, Recreation, and Tourism Commission know that the Council will be there to help when needed and thanked them for the hard work.

C. City Administrator Tom Corrigan –CSO continues to work on the Weed Abatement. He helps answer questions when people come into the office. He has been working on complaints about people living in RVs on City property. On April 19, there is a tentatively scheduled meeting for all the shareholders of Pacific Power. Engineer has firmly denied one proposed building plan because it did not meet all requirements.

Working with Rowan Fairfield, our Contract Planner, on the Transportation Growth Management Grant to update the Street Network Plan. All of the paperwork has been completed for Hunter at the shop.

Business Oregon announced that they will have the ability to apply for broadband funding. League of Cities is requesting a survey be completed on homelessness. RARE application submitted. Lieutenant Scott Waldon was here for a number of years and has retired. We supplied a patch and an old badge to complete a presentation. Jackson County Multi-Jurisdictional Natural Hazard Mitigation Plan is something we will bring back to discuss. Still working on getting our roads worked on. Mayor Ball – He received the survey regarding the homelessness and it needs to be added to our agenda and we need to deal with it as a City.
