#### V. STAFF REPORTS

Fire Chief Winfrey, FD4 – They had 91 calls for service. Two fires, one in Prospect and one in Sam's Valley. Budget is in process. They will be going from a part time Fire Chief to a full time Fire Chief and it will be fully funded for a forty hour

week and the new chief will be starting on June 5, 2023. They did purchase a chipper but does not know when they will get it. Still waiting on staffing grant.

Commission/Committee Reports:

Parks and Rec – Commissioner Pulcini stated Commissioner Smith will be commenting on her behalf.

Commissioner Smith- They do have a lot of events coming up and would like to get some volunteers signed up to help move along the events. At the last workshop there was a lot of input regarding the City Motto. They narrowed it down to nine ideas and would like to have ten, so they are wanting to send out a message to the community for ideas on the tenth one and they can reply by sending an email to City Administrator. Fliers with all of the information and how to reply, were sent to the school for students to take home.

Planning – Commissioner Sterling- The last meeting was a Type Three Land Use Public Hearing that dealt with a Vacation Rental By Owner on Steelhead Place that had a lot of public interest and comments. The application was ultimately denied. It is public record and information is here at the City Hall.

Mayor Ball – There are some very important issues on VRBO's here in the City and would like to direct Planning to head straight into them with codes. Need to discuss possibilities of getting it on the November Ballot. He would like planning to give Council some direction so needs to be added to the agenda for meeting in first part of May to discuss.

City Administrator- Tom Corrigan- Hiland repaired leaking pipe at the big bridge. Newsletter is out. Hunter has been working hard trying to get the business hookups going and then to Hunter home, that will expand to a lot of areas. Cyanotoxins, which comes from Cyanobacteria, which comes from algae blooms, is a new thing that we will have to track for TMDL. The Total Maximum Daily Load is what we can put into the river. The meeting with Pacific Power was interesting as we listened to three Engineers talk about many interesting topics. A new virus is out on computers called Zero Day Exploit. Everyone needs to update their search engines. Hunter at the shop should be done soon. The limb trailer is out again. Still working on some of the roads. Received clarification from Steve Lambert at the County on Sawyer Rd and we will need to take care of the first three hundred feet and have received one estimate so far.

Commissioner Pulcini- We are trying to be creative and put a booth together for the kids and make it exciting in introducing Shady Cove to the Community.

- -Festival on the Rogue June 4 at the Upper Rogue Regional Park.
- -Flag Raising Ceremony on Memorial Day, May 29 at the City Hall, with a pancake breakfast at the Upper Rogue Community Center.
