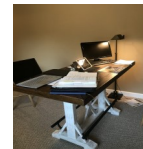

We also filled our newly renamed "Parks, Recreation and Tourism" Commission (or PRT for short). Again, we had more applicants than positions. All great applicants and hopefully long-time City volunteers.

Same goes for the Planning Commission and Budget Committee. We now have all positions filled and these groups are moving forward in a big way. Please see the Planning Commission article in this newsletter for updates on the work they are doing.

In addition to fully staffing our many Commissions and Committees, we have also managed to start the process of making real improvements to our City. Some will be realized soon, others will help set the City up for success moving forward.

First up, the City completed the upgrade to our Zoom meeting capabilities for better participation from remote connections. Please join not only the City Council meetings, but also the Planning Commission and maybe even a PRT meeting live via this greatly improved Zoom capability.

Next, Council has moved forward on and is working to finalize a large Digital Information Sign in front of City Hall. We hope to coordinate this with the same type of sign that will soon be installed at the Fire District #4 location. Together, these signs will be a great way of constant communication with the City's residents and a vital source of information in times of emergency.

With an eye toward our future, Council and our City Staff have tasked the updating and/ or refurbishing of our City welcome signs to the Parks, Recreation and Tourism Commission. Our goal is to begin energizing the City of Shady Cove with an updated "City Brand" and strive to make Shady Cove a destination for not just regional vacationers but also start to attract national tourism when possible. And we would like to accomplish this while not losing the small town rural feel we all love. What a mission right?

Thank you for allowing me to be your Mayor. JB

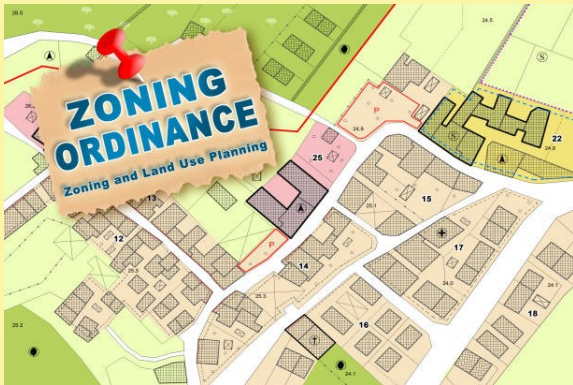

City of Shady Cove Planning Commission

WEED ABATEMENT—NOXIOUS VEGETATION ORDINANCE #304

EFFECTIVE: ALL YEAR ROUND!

WHAT IS NOXIOUS VEGETATION?

- ⇒ Weeds or grass more than 10 inches high.
- ⇒ Blackberry bushes that extend into a public thoroughfare or across a property line.
- ⇒ Poison oak or ivy.
- ⇒ Vegetation that is a health hazard because it is near other combustibles, or a traffic hazard because it impairs the view of the public thoroughfare or otherwise makes use of the thoroughfare hazardous for pedestrians and/or vehicles.

REMOVAL—RESPONSIBILITY

The owner, agent of owner and/or occupant of any lot or parcel of land within the limits of the City of Shady Cove shall cut and remove the weeds, grass, bushes and shrubbery growing thereon, or on adjacent and abutting streets all year round. If you are in the Floodplain ~ mowing and trimming is acceptable; however, complete removal of any vegetation will require a permit. ***For more information, please call or email City Hall for more information.***

NOTICE TO ABATE

It is expected that the property owner/occupant will comply voluntarily; however, should the owner/occupant fail or neglect to cut weeds, grass, or shrubbery as herein provided, the City shall serve a Weed Abatement Notice requiring that the property be abated within 14 days of notice.



WEEDS DECLARED NUISANCE

The growth of grass, weeds, shrubbery, and vegetation upon vacant and other lots and parcels of land, the streets and alleys abutting thereon, in the City, all year round. It constitutes a fire menace, and greatly increases the fire hazard in the City, and is declared to be a nuisance.



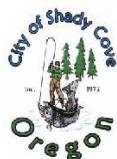
FIRE SEASON— RESTRICTIONS

When fire danger is “**High**” or “**Extreme**,” the Department of Forestry sets restriction levels that escalate according to the heat and dryness. Therefore, later in the summer, as fire danger worsens, using motorized equipment in combustible vegetation is allowed only until 1 p.m. or after 8 p.m., then until 10 a.m. and after 8 p.m., then not at all.

Celebrations, new City Welcome Signs, a City brand, and City beautification efforts. Fishing the Upper Rogue: What's Happening Now!

It is spring on the Upper Rogue so what do I fish for and where?

The Rogue River has four fish runs each year. 2 - Steelhead and 2 - Salmon

Let's break it down for current fishing conditions:

There is the Winter Steelhead run. This year, the Upper Rogue is experiencing a very late run but they have been showing good numbers since mid-March and continue to be active in the Upper Rogue. Guides have been hooking up daily as well as bank anglers. Here is the great part: the Summer Salmon run is officially on the board and the opportunity to catch both fish and a few trout are all in play for the avid fisherman.

Here are a few things to remember when fishing the Upper Rogue. Licensed anglers have a right to the river via the water up to the highwater mark. There is a lot of private property along the river so be respectful and ask permission for access as well as obeying the signs. Trout retention at any time is limited to stock fish only (ie. The Adipose fin is removed). Natural trout must be released unharmed.

Finally for this edition, remember that the "Holy Waters", the section of river above the Hatchery to the base of the dam, is always "Artificial flies, barbless, and Catch and Release only". The "Hatchery Hole" just below the Hatchery is closed most of the year with special restrictions when open. So be knowledgeable when you fish and avoid any unwanted outcomes.
