FEES OR TAXES

NONE, ONE, OR BOTH??



Shady Cove is a city that remains in the 1970's and 80's. Myself being a child of the late 70's and 80's, I believe it was the best time in our country's history (not to mention its music lives today and will always be the best in my opinion). The downside to that is the fixed tax rates established for Shady Cove in 1972-73 do not pay or support the economy or city infrastructure needed to make Shady Cove the city it needs to be today.

We have a very unique situation in our city. We are greatly divided between fixed income retired residents, aging veterans, and retirees who have come here to live out their lives in the beauty that is the Upper Rogue and Shady Cove. Add to the mix, the younger families that are caught in the difficult situation of wanting to raise their children in a rural environment and the affordability to do so. Each of these groups has different priorities, all of which are valid and must be considered.

So how do we move forward with catching up to just the standard norm of what is needed in city staffing, street maintenance, business growth, and the need for long-term water? And as if this isn't enough, throw in the next level of needs that include planning for a future for our city parks and youth involvement.

As a city, we can once again wait for a rich businessman to come in and build water infrastructure and other resources to help the city. Been there, done that. Didn't work real well long term. Alternatively, we can start working <u>together</u> for the future of Shady Cove.

Fees are a real hard issue for me as it is really nothing more than a tax equally placed on all residents. Fees don't differentiate between those more able to accept the increase and the ones who cannot. A tax, on the other hand, is based on the value of something, and so helps to spread the burden to all the community fairly. Those whose assets are worth more, pay more; Everyone else, pays less.

I know the word "TAX" is like calling your mother something not very nice, but a city is only as healthy, growing and inviting to people (new residents, businesses and tourists), when it is just that: healthy, growing and truly inviting.

During the last few years, I have heard, listened and read of some people (some not even residents of Shady Cove) call to "Unincorporate" the City. Anyone with any financial knowledge would see and acknowledge the great harm this would do to the residents of Shady Cove. Our property taxes make up a very small amount of our general fund and income to the City. The largest amount comes from the fact that the City IS incorporated, and these funds would be lost, crippling the community of Shady Cove, if we forego our "Incorporated" status.

On the flip side, I guess I also see that we as a city have maintained ourselves through all these years and could very easily just keep going that direction (with cuts to services as necessary, and even less maintenance and repairs as the cost skyrockets and the income to cover these items remains virtually the same as 40 years ago).

So SHADY COVE what do we do? Continue on our path towards none of the improvements we need? Or do we begin to change and grow in a way that best represents and supports our diverse population? In other words, find ways to increase revenue for the future of our city and its residents, both young, old, children and those to come...... *It is a question we need to answer together as a City and as a community of people working together.*

City of Shady Cove Planning Commission By: Commissioner Lena Richardson

Fifty years ago, Oregon adopted a landmark course of action, the Oregon Land Use Planning Program. In the 1960s and 1970s, rapid population growth in Oregon raised concerns about urban sprawl. In 1973, with the goal of protecting farm and forest land while controlling urban growth, the Oregon Legislature passed Senate Bill 100 creating the Department of Land Conservation and Development.

Oregon now has 19 statewide planning goals which require planning, management, and protection of agricultural land, forest land, open spaces, scenic and historical resources, natural resources, recreational opportunities, housing, transportation, and public access to beaches.

Oregon Land Use Law requires the state, counties, and cities to adopt a comprehensive plan consistent with the statewide planning goals and the zoning and development ordinances needed to put the plan into effect. Cities were given the authority to create planning commissions to make the local decisions required to conform to their stateapproved comprehensive plan and ordinances and to make recommendations to City Council.

Any decisions made by the Planning Commission must be in conformance with our local comprehensive plan and ordinances as well as state land use law. Personal opinions of Planning Commissioners have no relevance in decision-making. All decisions may be appealed to the City Council and the Oregon Land Use Board of Appeals.

Fifty years ago, Oregon created a benchmark program for responsible land use management. The first of the 19 planning goals is citizen involvement, not just at the state level but at all levels of government throughout the state.

PROTECT THE RIPARIAN ZONE

Before doing any work within 75 feet of the Rogue River, please ensure that you have the proper riparian permit(s). Violators may be subject to fines and restoration of the damaged area(s).

WEED ABATEMENT-NOXIOUS VEGETATION Ordinance #304

EFFECTIVE: ALL YEAR ROUND!

WHAT IS NOXIOUS VEGETATION?

- \Rightarrow Weeds or grass more than 10 inches high.
- ⇒ Blackberry bushes that extend into a public thorough-fare or across a property line.
- \Rightarrow Poison oak or ivy.
- ⇒ Vegetation that is a health hazard because it is near other combustibles, or a traffic hazard because it impairs the view of the public thoroughfare or otherwise makes use of the thoroughfare hazardous for pedestrians and/ or vehicles.

REMOVAL—RESPONSIBILITY

The owner, agent of owner and/or occupant of any lot or parcel of land within the limits of the City of Shady Cove shall cut and remove the weeds, grass, bushes and shrubbery growing thereon, or on adjacent and abutting streets all year round. If you are in the Floodplain \sim mowing and trimming is acceptable; however, complete removal of any vegetation will require a permit. NOTICE TO ABATE

It is expected that the property owner/occupant will comply voluntarily; however, should the owner/occupant fail or neglect to cut weeds, grass, or shrubbery as herein provided, the City shall serve a Weed Abatement Notice requiring that the property be abated within 14 days of notice.



The growth of grass, weeds. shrubbery, and vegetation upon vacant and other lots and parcels of land, the streets and alleys abutting thereon, in the City, all year round. It constitutes a fire menace, and greatly in-



creases the fire hazard in the City, and is declared to be a nuisance.

FIRE SEASON— RESTRICTIONS

When fire danger is "High" or "Extreme," the Department of Forestry sets restrictions levels that escalate according to the heat and dryness. Therefore, later in the summer, as fire danger worsens, using motorized equipment in combustible vegetation is allowed only until 1 p.m. or after 8 p.m., then until 10 a.m. and after 8 p.m., then not at all.

Fishing the Upper Rogue: What's Happening Now!

September 1st thru October 31 from the Fishers Ferry boat launch upstream to the Cole Rivers Hatchery Dam—gear is restricted to artificial flies only, with no added weights or attachments except a bubble or similar floating device attached to the line.


This area is also closed for Chinook salmon beginning Sept. 1, but remains open for hatchery steelhead retention, and wild steelhead catch-and-release angling. Always beware of the regulations for the area of the Rogue river you are fishing. More importantly to the average angler a word of caution during these months (and always really), if wading or drifting the Rogue be very attentive of the Salmon Redds (spawning areas). You see there are gravely areas where you will actually see Salmon spawning and splashing about. It is great experience to see and should definitely be avoided by humans.

The Holy Waters usually go off during a week or two during the fall and the insect hatch is just right. All artificial flies, barbless and catch and release unharmed. I find it easier to watch the most experienced local guides and fly fisherman to know when this happens. If they are hard to reach but are carrying their rods in the vehicle, that is a good indication.

Fall can be a great time to fish our area's lakes. The crowds have grown much smaller and the reservoirs are lower, condensing the fish. Cooler weather cools the water and the trout become more active. For a great chance at a Trophy fish, from a lake, Diamond Lake is usually a great bet in late September and early October.

Depending on the lake, still fishing with Powerbait or drifting Nightcrawlers is a great approach. If you have a boat and can launch it try to find the current at the bottom of Lost Creek Lake and troll deep with flashers and Wedding Ring lures (tipped with a worm).

And lastly, for the next couple of months before winter sets in the Rogue River above Lost Creek Lake and Prospect in peaceful, beautiful and loaded with hold-over trout from the summer stockings. Rumor has it that it is often a location for fall drops of Trophy sized over-stock if the reservoirs are to low to get them.... Tight lines.





Brief History of Shady Cove, Oregon

Before European settlers arrived, the land that is now Shady Cove was inhabited by the Takelma Native American tribe. These indigenous peoples relied on the abundant resources provided by the river and surrounding forests for sustenance and shelter.

Settlers started moving into the area, spreading out from Trail, in the 1870's. The Postal Service did not establish an office in a place called Shady Cove until September 12, 1939, a Mrs. Lillian Hukill as postmistress. According to a local historian, the name for Shady Cove came from a speculative operation by some Medford businessmen. They bought some land for summer homes on the east side of the Rogue River and called their business "Shady Cove Country Club".
